

PRIVACY POLICY

The protection of privacy and compliance with data protection regulations are of great concern to the European Federation of Periodontology National Society (hereinafter "EFP"), therefore we inform you, through this Policy, how we process your personal data. This Policy includes the general rules that govern the collection of data through its web pages, sites, or applications.

The user of this website is informed of the processing of data supplied to EFP, through: contact forms; those generated through browsing the website and any other future means; as well as data communications that may be made to the entity by different means, all for the purposes indicated in this Policy.

A. Who is the Data Controller?

B. What type of personal data do we process?

If applicable, if the interested party registers as a user on the EFP website, the following personal data will be processed:

- User name;
- E-mail address;
- Name and surname;
- IP address:
- Date of birth and sex.

Additionally, if the interested party contacts EFP through the "Contact" section, the data that will be processed by EFP will be:

- Name and surname;
- Email;
- Telephone;
- The personal data that may be contained in the body of the message.

The user guarantees the accuracy and veracity of the personal data provided and undertakes to keep them duly updated and to inform EFP of any variation that may occur in them.

EFP does not accept to receive information or personal data from third parties provided by the user. Therefore, in the event that the user communicates personal data from third parties, EFP assumes that the user has the necessary legitimacy to do so.

C. For what purposes do we process your personal data and on what basis do we do so?

- I. Purposes based on the legitimate interests pursued by EFP:
 - Manage and resolve bugs or issues and provide maintenance services on our Websites and apps, if necessary.
 - Respond to requests, messages or exercise of rights sent by users and interested parties.
- II. Purposes based on the user's consent given on the registration on the website:
 - Manage the relationship with the Registered user.
 - Maintain a register of users.
 - Share with the user the information corresponding to his registration and the actions carried out as such user.
 - Any other complementary information or information necessary for the proper fulfilment and development of the relationship between EFP and the user.
 - If authorised by the user registered with EFP, sending of newsletters.
 - Event Management.

D. How long will we store your data?

Personal data provided by the user will be kept until the end of EFP's relationship with him.

In any case, they shall be kept for a certain period of time on the basis of the following criteria: (i) legal obligation for EFP to retain; (ii) duration of the relationship and consultations with the user; (iii) request for deletion by the data subject in appropriate cases; and, if the case, (iv) inactivity of the user account for a period of time.

In addition, EFP undertakes to process and collect personal data:

- In a lawful, fair and transparent manner,
- In an appropriate, relevant and limited way,
- For as long as is strictly necessary.

EFP also undertakes to respect the principles of Privacy by design and by default, as well as the accountability principle established in the data protection regulations.

E. Will we share your data with third parties outside EFP?

We inform you that your data may be processed by third parties outside the Controller in two circumstances: (i) a processing order from EFP to a service provider, or (ii) a transfer of data to third parties by a legal obligation or by request of an Authority.

The Controller may have third party service providers who may process your personal data for the proper provision of services such as maintenance of the website or management of events.

The processing of data carried out by these third parties will be done to comply with the purposes described in section "Purposes of the processing" and being legitimate to do so based on a Data Processing Agreement (DPA) signed between the provider and The Controller.

We remind you that on our Websites may be cookies installed by third parties that collect your personal data if you accept them. We invite you to visit our Cookie Policy for more information on this subject.

F. What rights do you have with regard to the processing of your data?

The data subject may exercise his/her rights according to the following information, and with regard to the limitations of the rights included in the data protection regulations.

Access	Right to obtain from the Controller confirmation as to whether or not personal data concerning him or her are being processed, and, where that is the case, access to that personal data.	
Rectification	Right to obtain from the controller the rectification of inaccurate personal data concerning him or her.	
Erasure	Right to obtain from the controller the erasure of personal data concerning him or her in certain circumstances.	The data subject may exercise

Restriction of processing	The data subject shall have the right to obtain from the controller restriction of processing where one of the following applies: • The accuracy of the personal data is contested by the data subject, for a period enabling the controller to verify the accuracy of the personal data; • the processing is unlawful and the data subject opposes the erasure of the personal data and requests the restriction of their use instead;	dataprotection@efp.org In any case, the data subject shall indicate which right is exercising and if the case, the needed additional information You must bear in mind that in order to exercise your rights you must attach a copy of your ID or other document proving your identity.

 the controller no longer needs the personal data for the purposes of the processing, but they are required by the data subject for the establishment, exercise or defence of legal claims; You should also bear in mind that EFP will respond to your request within the established legal deadlines and taking into account the current legal framework.

 the data subject has objected to processing pending the verification whether the legitimate grounds of the controller override those of the data subject.

Withdraw of the given consent

The data subject shall have the right to withdraw his or her consent at any time.

Portability

The data subject shall have the right to receive the personal data concerning him or her, which he or she has provided to a controller, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller.

Likewise, if you consider that EFP has not processed your personal data in accordance with the applicable regulations, you may submit a complaint to the relevant Data Protection Agency. However, we kindly ask you to contact us prior to making a complaint, through the channels indicated, in order to be able to deal more quickly with your request and clarify any doubts that may arise.

If you exercise your rights, it is possible that your data will remain blocked at the disposal of the competent authorities, in accordance with the data protection regulations, to attend to the possible responsibilities arising from the processing.
